A. **SUBJECT TO** the conditions referred to in Deed of Transfer dated 22 July, 1918, no. 7045.

B. **SUBJECT FURTHER** to the following condition contained in Deed of Grant dated 15 November, 1817 in favour of Gerrit Reynier van Rooyen Uitenhage Quitrent, Volume 2, Folio 15:

"en zal gehouden zijn (volgens de existerende Wetten deser Volkplanting) zorge te dragen, dat de Limieten behoorlijk worden gemerktekend, en het Land in zulk een staat van cultivatie gebracht worde, als waar toe hetzelve bekwaam mogte wezen en zulks binnen den tyd van de eerste drie jaren; en ook dat dit tegenwoordig uitgegeven wordende Land boven dien subject zal zijn aan alle zoodanige Impostiën en Gerechtigheden, als er bereids op diergelyke Landerijen zijn gemaakt of in der tyd zullen gemaakt worden."

C. **ENTITLED TO** the following special condition contained in Deeds of Transfer dated 27 February 1907, nos. 1525, 1526, 1527, 1528, 1529, in favour of C. Mostert, J.W. Gerber, W.P.J. Mostert, W.H. Moolman respectively:

"That the fountain marked n on the diagram of Lot T is common to the proprietors of Lots T and M; From m to n is a 20 feet right of way."

D. **SUBJECT FURTHER TO** the following servitude endorsement endorsed on Deed of Transfer No. 3852 dated 21 March, 1963, which reads as follows: -

"Kragtens Notariële Akte Nr. 62/1968 geregistreer hierdie dag is die uitoefening van die regte toegeken kragtens Not. Akte 303/66 soos in endossement gedateer 2-5-1966 hierop, oorgedra aan die Trustee vir die toekomstige plaaslike owerheid van die dorp Kaap St. Francis."



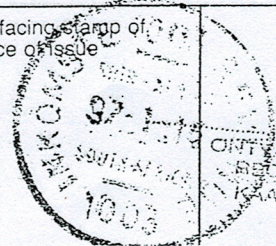
